

**STATE OF ARKANSAS
 CERTIFICATION OF REAL PROPERTY TAX REDUCTION
 ----- November 15, 2020 DEADLINE -----**

Pursuant to Arkansas Code Annotated § 26-26-310, on or before November 15 of each year, the county collector of each county shall certify to the Chief Fiscal Officer of the State the amount of the real property tax reduction provided in Arkansas Code Annotated § 26-26-1118. After receipt of this certification from the county collectors, the Chief Fiscal Officer shall determine the proportionate share of the total statewide reduction attributable to each county. Failure to file a timely certification will result in a delay of the county receiving the reimbursement.

I certify below the amount of property tax reduction for the **2019 assessment year**. I also certify that only property which includes a dwelling of a person's principal place of residence has been granted the reduction for which I am requesting reimbursement. In no event shall a property tax credit for the 2019 assessment year be allowed a property owner after October 15, 2020. I understand that the Legislative Auditor, or the Legislative Auditor's designee, shall audit the books and records of the county assessor, county collector, or any other party as needed to ensure that the amount of the property tax reduction is accurate. The Chief Fiscal Officer of the State shall have the authority to adjust the amount certified by the county collector if it is discovered that the certified amount is incorrect.
