

BE IT ENACTED BY THE QUORUM COURT OF THE COUNTY OF FAULKNER, STATE OF ARKANSAS; AN ORDINANCE TO BE ENTITLED: AN ORDINANCE REQUIRING PROPERTY OWNERS WHOSE GEOGRAPHICAL PROPERTY BOUNDARIES ARE LOCATED WITHIN 300 FEET OF A PUBLIC SEWER SYSTEM AND FOR OTHER PURPOSES.

WHEREAS, the Faulkner County Waterworks and Sewer Public Facilities Board (hereinafter "the Board") was created by the Faulkner County Quorum Court; and

WHEREAS, the Board, in conjunction with the Arkansas Department of Natural Resources and the Arkansas Department of Economic Development has begun funding and financing a public sewer system in Faulkner County; and

WHEREAS, in consideration of the environmental quality needs of Faulkner County and, specifically, Faulkner County's Lake Conway Water Basin, the Board funded and constructed a public sewer system to serve the specifically delineated aforementioned geographical area; and

WHEREAS, in furtherance of addressing the above-stated environmental quality needs, and pursuant to Arkansas Department of Health Rules and Regulations Pertaining to General Sanitation § 7(C), connection to the public sewer system is required of all homes and businesses located within 300 feet of the public sewer system and having adequate access.

NOW, THEREFORE, BE IT ORDAINED BY THE QUORUM COURT OF FAULKNER COUNTY, ARKANSAS, THAT:

Section 1: The owner, whether in fee simple or some lesser estate, of all houses, buildings, or properties situated within Faulkner County and used for human occupancy, employment, recreation, or other purposes, the property line of which is now, or may be within the future, within 300 feet of a public sanitary or combines sewer system of the County or the County's Public Facilities Board is hereby required to, at the owner(s)' own expense, install suitable toilet facilities therein and to connect such facilities directly with the proper public sewer in accordance with the provisions of this Ordinance within 30 days after the date of official notice to perform such act.

Section 2: Any person found to be in violation of any provision of this Ordinance shall be served with written notice identifying specifically the nature of the violation and affording the person in violation 30 days within which to satisfactorily remedy the violation. Any person who willfully fails to satisfactorily remedy the violation shall be guilty of a misdemeanor and, upon

Section 3: No provider of water services shall provide water to a person in violation of this ordinance if said agency is notified by Faulkner County.

Section 4: Severability – In the event any portion of this ordinance is declared or adjudged invalid or unconstitutional, such declaration or adjudication shall not affect the remaining portions of this ordinance, which shall remain in full force and effect as if the portion so declared or adjudged invalid or unconstitutional was not originally a part of this ordinance and the remaining portions of the ordinance shall be executed fully and faithfully.


Section 5: All ordinances in conflict herewith are repealed to the extent of the conflict.

Section 6: An emergency is hereby declared to exist as this Ordinance is necessary for the proper and timely conduct of county operations and this Ordinance shall be in force and take effect upon passage and publication.

BE IT ENACTED BY THE QUORUM COURT OF THE COUNTY OF FAULKNER, STATE OF ARKANSAS, AN ORDINANCE TO BE ENTITLED: AN ORDINANCE DESIGNATING THE FAULKNER COUNTY COLLECTOR TO COLLECT AND THE FAULKNER COUNTY TREASURER TO REMIT VOLUNTEER FIRE DEPARTMENT DUES

WHEREAS, several volunteer fire departments have requested the Quorum Court enact an ordinance for the collection and remittance of dues to each of the requesting volunteer fire departments; and

WHEREAS, pursuant to A.C.A. § 14-20-108, the Faulkner County Quorum Court, upon request by one (1) or more volunteer fire departments in the county, may authorize a county official to collect and remit to the department or departments the annual or quarterly dues charged by the department or departments in consideration of providing fire protection to unincorporated areas in the county.

NOW, THEREFORE, BE IT ORDAINED BY THE QUORUM COURT OF THE COUNTY OF FAULKNER, STATE OF ARKANSAS THAT:

Section 1: The following volunteer fire departments serving portions of the unincorporated areas in Faulkner County have requested their dues be collected and remitted to them by the Faulkner County Collector and the Faulkner County Treasurer, respectively:



ORDINANCE 09-11

BE IT ENACTED BY THE QUORUM COURT OF THE COUNTY OF FAULKNER STATE OF ARKANSAS, AN ORDINANCE TO BE ENTITLED: AN ORDINANCE CREATING THE OFFICIAL POSITION OF COUNTY JAIL DOCTOR.

WHEREAS, the County of Faulkner is required by the State of Arkansas to operate a County Jail to hold persons awaiting trial in the Courts of Arkansas; and

WHEREAS, the Sheriff is the elected official required to operate the County Jail and has the affirmative duty to avoid deliberate indifference to the protection of needs of persons whose liberty has been taken by virtue of jail detention, including, but not limited to necessary health care needs; and

WHEREAS, “necessary health care” includes medical, pharmaceutical, dental, and mental treatment; and

WHEREAS, health care must be treatment that is reasonable and adequate under the circumstances; and

WHEREAS, neither the Sheriff nor the Sheriff's jailers are licensed health care professionals and there is need of the services of a physician as a part of the system for the provision of necessary health care to the detainees of the Faulkner County Jail;

WHEREAS, the County is a member of the Association of Arkansas Counties Risk Management Fund (the AACRMF);

WHEREAS, the AACRMF's General Liability Protection Agreement provides, in Section 1.1., that “[u]nless protection is excluded elsewhere in this agreement, the Fund will pay on *behalf of the Member* all sums which the Member shall be legally (specifically excluding any liability for which immunity is provided by either statutory law or common law) obligated to pay us ultimate net loss on account of civil rights liability (or tort liability for which there is no immunity) because of: ... County Officials' Errors and Omissions, ... or other County Operations;”

WHEREAS, the AACRMF's General Liability Protection Agreement provides, in Section 7.4., that “Civil Rights Liability” means damages imposed upon a member and arising out of a violation of the U.S. or Arkansas Constitution or Federal or Arkansas Civil Rights Statutes caused by the Named Member or an official ... of the Named Member acting within the course of that official's or employee's official duties on behalf of the Named Member and not otherwise excluded by this agreement [but that] Civil Rights Liability shall not include any tort or other claim for which immunity is provided by law and all immunity provided by law and all immunity provided by U.S. or Arkansas law including but not limited to “Tort Immunity” provided by Act 165 of 1969 (Ark. Code Ann. 21-9-103, et seq.), which immunity is expressly claimed;”

WHEREAS, the AACRMF's General Liability Protection Agreement provides, in Section 7.9., that "Errors and Omissions' means conduct that is contrary to an affirmative duty to act or conduct omitted in the face of an affirmative duty to act (and does not mean negligence nor does it mean that any protection is provided for negligence liability because statutory tort immunity and all other immunity is expressly claimed and is not waived);"

WHEREAS, the AACRMF's General Liability Protection Agreement provides, in Section 2.1.1., that "[t]his agreement does not provide protection for allegations of, claims arising out of, or liability on account of ... [n]egligence, including negligence of any degree;"

WHEREAS, the AACRMF's General Liability Protection Agreement provides, in Section 2.4.5., that [t]his agreement does not apply to, does not provide protection for, and does not provide defense for ... Health Care Providers, including hospitals, nursing homes, and other health care facilities or the employees thereof;"

WHEREAS, the AACRMF's General Liability Protection Agreement provides, Section 3.1, entitled, "Defense Duty," that "the Fund shall have the right ... to defend any suit against the Member seeking recovery of damages for which protection is provided by this Agreement allegedly due on account of improper or omitted performance by ... an official ... of the Named Member in the performance of his or her official ... duties on behalf of the Named Member in accord with the official policy of the Named Member including (for the purpose of asserting tort immunity which is expressly not waived by any Member) any such suit claiming a right to recover damages in tort even if any of the allegations for damages are groundless, false, fraudulent, or unavailable by law (and may make such investigation and settlement of any claim or suit as it deems expedient and as is permitted by Ark. Code Ann. 21-9-302) ... ;

WHEREAS, the AACRMF's General Liability Protection Agreement provides, in Section 4.1.2., entitled "Members Defined," that "[e]ach of the following is a Member under this Agreement to the extent set forth below ... : ... [a]ny elected or appointed official ... while acting within his or her official or employee capacity in the performance of government activities of the Named Member pursuant to the official policy of the named member;"

NOW THEREFORE, BE IT ENACTED BY THE QUORUM COURT OF FAULKNER COUNTY, ARKANSAS:

1. POSITION. The official position of County Jail Doctor is hereby created for the purpose of providing Sheriff access to a physician as a part of the Sheriff's duty to avoid deliberate indifference to the protection of needs of persons, including the necessary health care needs of jail detainees.

2. APPOINTED COUNTY OFFICIAL. Having created this position, the County Jail Doctor qualifies as an "appointed official" as that term is used in Section 4.1.2. of the AACRMF's General Liability Protection Agreement in order that the County Jail Doctor is eligible for AACRMF protection as a "Member." This necessarily includes the County Jail Doctor, individually and through his designated staff (including any nurses the County Jail Doctor asks to assist him and other health care personnel providing services at the jail, over the phone, at the doctor's office or at other locations to which jail detainees are provided health care services under the direction of the County Jail Doctor.

3. AACRMF PROTECTION. It is understood that the County Jail Doctor is not eligible for


AACRMF protection for any alleged medical malpractice liability as a health care provider but that the County Jail Doctor and/or the County Jail Doctor's nursing staff acting for the County Jail Doctor, would be eligible -- as an appointed county official -- for AACRMF protection for alleged civil rights liability, for alleged tort liability and for AACRMF lawsuit defense services related thereto (including the assertion of any immunity as an appointed county official).

4. EMERGENCY CLAUSE. The adoption of this Ordinance is necessary for the proper and efficient administration of the Faulkner County Jail and for the preservation of the health, safety, and welfare of the residents of Faulkner County, Arkansas; therefore, an emergency is hereby declared to exist, and this Ordinance shall be in full force and effect immediately upon its passage.



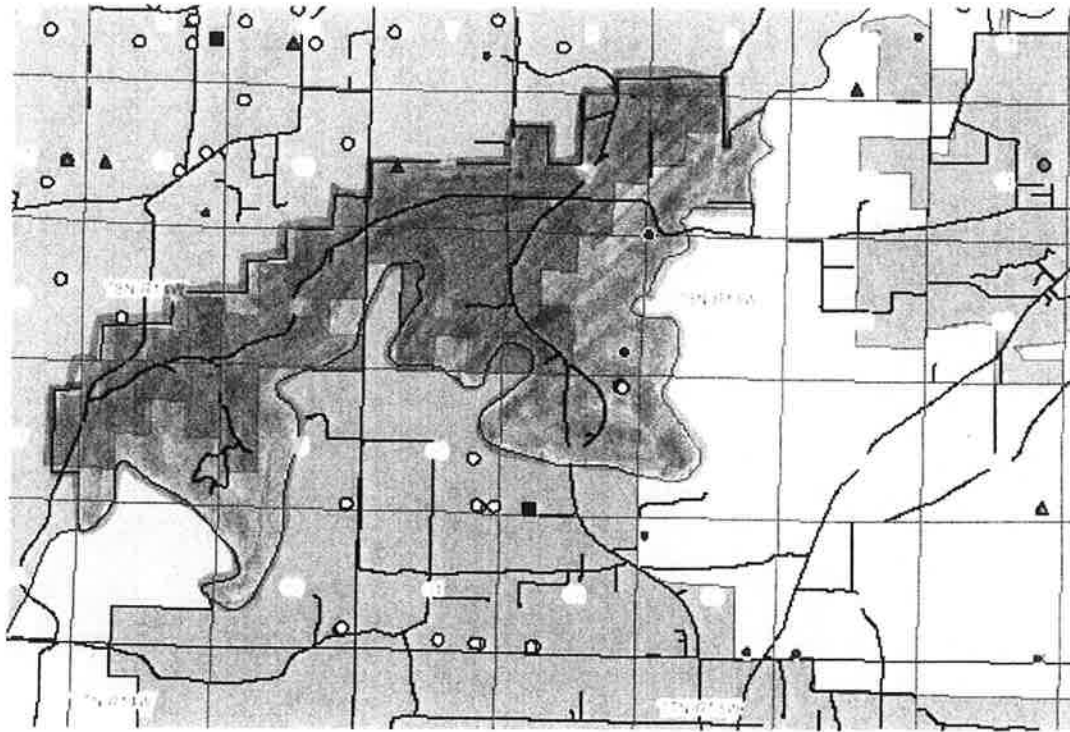

AN ORDINANCE AUTHORIZING THE LEVY AND ASSESSMENT OF AN ADDITIONAL TWENTY DOLLAR (\$20.00) FINE TO DEFRAY THE COSTS OF INCARCERATING PRISONERS IN THE COUNTY DETENTION CENTER PURSUANT TO ACT 209 OF 2009; TO REPEAL ORDINANCE 03-14 TO THE EXTENT IT IS INCONSISTENT WITH THIS ORDINANCE; AND FOR OTHER PURPOSES.

WHEREAS, on or about July 16, 2003, the Faulkner County Quorum Court enacted Ordinance 03-14 which, among other things, provided for the levying of an additional five dollar (\$5.00) fine to help defray the expenses associated with incarcerating prisoners in the Faulkner County Detention Center; and

WHEREAS, Act 209 of 2009 (codified at Ark. Code Ann. § 16-17-129) amended the previously mentioned code section so as to increase the additional levy from five dollars (\$5.00) to twenty dollars (\$20.00) from each defendant upon each conviction, each plea of guilty or nolo contendere, or each bond forfeiture in all cases in the first and second class of accounting records as described in Ark. Code Ann. § 16-17-707; and

WHEREAS, all sums collected from the additional fine shall be paid into the county treasury and deposited into a fund to be used exclusively to assist in defraying the costs of construction, maintenance, and operation of the detention center; transporting and incarcerating county or city prisoners; purchase and maintenance of equipment for the detention center; and, training, salaries, and certificate pay for detention center personnel; and

WHEREAS, the revenues derived from the additional fines levied shall not offset or reduce funding from other sources for the maintenance, operation, and capital expenditures of the detention center; and

WHEREAS, it is in the best interests of the citizens of Faulkner County for the additional twenty dollar (\$20.00) fine to be adopted and imposed upon those who are convicted, plead guilty or nolo contendere, or forfeit a bond so as to defray the costs, generally borne by the tax payers, associated with the maintenance, operation, and capital expenditures of the detention center.

NOW THEREFORE BE IT ORDAINED BY THE QUORUM COURT OF FAULKNER COUNTY, ARKANSAS:

Section 1: Authority – Pursuant to Act 209 of 2009, codified as Arkansas Code Annotated section 16-17-129, the Faulkner County Quorum Court hereby levies an additional fine in the amount of twenty dollars (\$20.00) upon each defendant’s conviction, each plea of guilty or nolo contendere, or each bond forfeiture in all cases in the first and second class of accounting records as described in Ark. Code Ann. § 16-17-707.

Section 2: Deposit of Funds – The monies collected pursuant to this Ordinance shall continue to be deposited in the “Jail Fines” fund (Fund 31).

Section 3: Collection – All District Courts within Faulkner County shall immediately, upon adoption and passage of this Ordinance, begin levying and collecting the fine prescribed herein and remit those revenues derived therefrom to the Faulkner County Treasurer on a monthly basis as required by Act 209 of 2009. All remittances must be received by the Treasurer on or before the 5th day of each month.

Section 4: Purpose – All sums collected from the additional fine shall be used exclusively to assist in defraying the costs of construction, maintenance, and operation of the detention center; transporting and incarcerating county or city prisoners; purchase and maintenance of equipment for the detention center; and, training, salaries, and certificate pay for detention center personnel.

Section 5: Repealer – All laws or parts of laws in conflict with this Ordinance, including specifically but not limited to Ordinance 03-14, are hereby repealed to the extent of the conflict.


Section 6: Severability – If any provision of this ordinance is held invalid, such invalidity shall not affect the remaining provisions of the ordinance which remains effective absent the invalid provision, and to this end, the provisions of the ordinance are declared to be severable.

Section 7: Emergency Clause – In order to protect the Faulkner County taxpayers’ investment in the Faulkner County Detention Center and to provide for necessary administrative and enforcement authority to manage the Faulkner County Detention Center, an emergency exists, and this ordinance, being for the immediate preservation of the public peace, health, and safety shall be in full force upon the legislatively imposed effective date of July 1, 2009, in addition to passage, approval, and publication by the local officials.

BE IT ENACTED BY THE QUORUM COURT OF THE COUNTY OF FAULKNER, STATE OF ARKANSAS, AN ORDINANCE TO BE ENTITLED: AN ORDINANCE APPROVING THE CITY OF VILONIA'S FIRE DEPARTMENT PROVIDING FIRE PROTECTION SERVICES OUTSIDE ITS GEOGRAPHICAL BOUNDARIES, SPECIFICALLY THE AREA CURRENTLY PROTECTED BY THE EAST CYPRESS VOLUNTEER FIRE DEPARTMENT, CONSTRUCTING OR ALTERING NECESSARY FACILITIES, AND OTHER PURPOSES

WHEREAS, the East Cypress Volunteer Fire Department, subsequent to a unanimous vote by its governing body, desires the Vilonia Fire Department to provide fire protection services for the area currently protected by the East Cypress Volunteer Fire Department; and

WHEREAS, in order to prevent the destruction by fire of property located outside the corporate limits of the City of Vilonia and in order to lessen the loss caused on account of insufficient means to combat fires and as a protection against such loss, the city council or other governing body of Vilonia, having an organized fire department, may provide by ordinance that the fire fighting machinery and equipment, with the necessary fire fighters to operate it, may be used to combat fires beyond the corporate limits of any city or town.

WHEREAS, pursuant to A.C.A. § 14-53-102, the Vilonia City Council, upon request by the City Vilonia Fire Department and the East Cypress Volunteer Fire Department Board, authorized the Vilonia Fire Department to provide the necessary fire protection services to that area currently protected by the East Cypress Volunteer Fire Department which is outside the geographical boundaries of any municipality.

NOW, THEREFORE, BE IT ORDAINED BY THE QUORUM COURT OF THE COUNTY OF FAULKNER, STATE OF ARKANSAS THAT:

Section 1: Pursuant to A.C.A. § 14-53-102, the Vilonia Fire Department is hereby authorized to operate beyond its corporate limits to the extent of the geographical area currently served by the East Cypress Volunteer Fire Department; and

Section 2: The East Cypress Volunteer Fire Department, by and through its board, unanimously desires to relinquish the right to provide fire protection services to the area currently served and the Vilonia Fire Department agrees to accept the responsibility to provide fire protection services.

Section 3: Pursuant to A.C.A. § 14-53-102 and as a result of the abovementioned agencies' requests, the Faulkner County Quorum Court authorizes, in conjunction with the ability to operate beyond Vilonia's corporate limits, the Vilonia Fire Department to provide services to the unincorporated area currently protected by the East Cypress Volunteer Fire Department and to construct or alter necessary facilities in furtherance of the area's fire protection.



A copy of said budget shall be filed in the Office of the County Clerk and shall be available for inspection and copying by any person during normal business hours.

Section 2: NONRESTRICTED EXPENDITURE CATEGORIES.

Expenditures of funds appropriated by this Ordinance shall not be restricted to the line item expenditure codes comprising the four major categories of expenditures - Personal Services, Supplies, Other Services and Charges and Capital Outlays, but shall be restricted to office/departmental expenditures.

Section 3: EXPENDITURE RESTRICTED TO SPECIFIED FUNDS.

No expenditure of appropriated funds shall be made from any fund other than the fund specified in the Ordinance or an amendment thereto.

Section 4: TRANSFERS.

Any transfer of monies between the various funds of the County or between the four major categories of expenditures - Personal Services, Supplies, Other Services and Charges, Capital Outlays - shall be made only with prior approval of the Faulkner County Quorum Court. Provided, however, all transfers budgeted for in the annual budget shall be exempt from the provisions of this section.

Section 5: REPEALER.

All ordinances and parts of ordinances in conflict with this ordinance are hereby repealed. If any provision of this ordinance or the application thereof to any person or circumstance is held to be invalid, such invalidity shall not affect other provisions or application of the ordinance which can be given effect without the invalid provision or application, and to this end the provisions of this ordinance are declared severable.

Section 6: EFFECTIVE DATE.

This ordinance is adopted to comply with the provisions of A.C.A. § 16-34-101 et seq and shall be effective as of January 1, 2010.


