I also certify that only property which includes a dwelling of a person's principal place of residence has been granted the reduction for which I am requesting reimbursement. In no event shall a property tax credit for the 2023 assessment year be allowed a property owner after October 15, 2024. I understand that the Legislative Auditor, or the Legislative Auditor's designee, shall audit the books and records of the county assessor, county collector, or any other party as needed to ensure that the amount of the property tax reduction is accurate. The Chief Fiscal Officer of the State shall have the authority to adjust the amount certified by the county collector if it is discovered that the certified amount is incorrect.
