**WHEREAS**, Faulkner County solicited bids on a 2025 Pick-up Truck to be opened on April 21, 2025 at 8:30 a.m.; and


**WHEREAS**, Faulkner County received a single bid from Smith Ford in Conway, AR, which also included a proposal for trading in a 2022 Ford Edge.
