ORDINANCE 25-01

(Sponsored by Justice Lachowsky)

BE IT ENACTED BY THE QUORUM COURT OF THE COUNTY OF FAULKNER, STATE OF ARKANSAS, AN ORDINANCE TO BE ENTITLED: AN ORGANIZATIONAL ORDINANCE FOR THE 2025-2026 QUORUM COURT.

WHEREAS, the term for the new Quorum Court began on January 1, 2025, and an organizational ordinance for the new Quorum Court is needed; and,

WHEREAS, the Quorum Court desires to establish its regular meeting schedule by ordinance pursuant to Arkansas Code Annotated § 14-14-904, and the Court finds that it is in the best interests of the Court to do so.

NOW, THEREFORE, BE IT ORDAINED BY THE QUORUM COURT OF FAULKNER COUNTY, ARKANSAS, THAT:

- Article 1: Unless modified by subsequent ordinance, the regular monthly meeting of the Quorum Court shall hereafter be held on the Third (3rd) Tuesday at 6:00 p.m. on January, February, March, April, May, June, July, August, October, November and December. Due to the annual Faulkner County Fair Parade, the monthly meeting of the Quorum Court for September will occur on the Third (3rd) Thursday at 6:00 p.m.
- Article 2: The regular monthly meetings of the Quorum Court shall be held at the Faulkner County Courthouse, Courtroom A. If Courtroom A is unavailable, the Justices of the Peace will be timely notified of the meeting location by the Secretariat.
- Article 3: The regular monthly meeting of the Budget and Finance Committee shall be held on the Second (2nd) Tuesday of every month at 6:00pm. If the Chairperson or a quorum of the Budget & Finance Committee shall deem it necessary, the date and time of the meeting may be changed as needed.
- Article 4: The regular monthly meetings of the Budget and Finance Committee shall be held at the Faulkner County Courthouse, Courtroom A. If Courtroom A is unavailable, the committee members will be timely notified of the meeting location by the Secretariat.

Article 5: The following regular committees are hereby established to serve the Faulkner County Quorum Court: Budget & Finance, Infrastructure, Courts and Public Safety, and Personnel. Each regular committee shall comprise of five members.

Each committee shall be tasked with the following legislative responsibilities:

- (a) Budget & Finance. The duties of the Budget & Finance Committee shall include, but not be limited to, the following:
 - 1. Consider and/or recommend proposed budgetary items to be presented to the Quorum Court for consideration and final passage or action; and
 - 2. To submit the following year's budget or amend the existing budget; and
 - 3. Review revenue and expenditure projections; and
 - 4. Assess county government programs and operations and recommend sustainable financing arrangements for priority needs.
- (b) Personnel. The duties of the Personnel Committee shall include, but not be limited to, the following:
 - 1. Consider all requests to create or eliminate county employment positions; and
 - 2. Review pay raise requests to ensure reasonableness; and
 - 3. Develop personnel policies.
- (c) Infrastructure. The duties of the Infrastructure Committee shall include, but not be limited to, the following:
 - 1. Consider and/or recommend proposed infrastructure items to be presented to the Quorum Court for consideration and final passage; and
 - 2. Review proposed infrastructure improvements within the County; and
 - 3. Develop ordinances relating to the County's transportation system, water & sewer systems, and other community projects.
- (d) Courts & Public Safety. The duties of the Courts & Public Safety Committee shall include, but not be limited to, the following:
 - 1. Consider and/or recommend proposed ordinances which pertain to the County's court or public safety systems; and
 - 2. Review proposed improvements within the County's courts and public safety systems; and
 - 3. Develop ordinances relating to the improvement of the County's courts and public safety systems.

Article 6: The Quorum Court and all the Committees thereof shall be procedurally governed by the most current edition of the Democratic Rules of Order and shall include the following procedures:

- (a) The Democratic Rules of Order may not overrule or supersede any state statute regarding the governance of the Quorum Court.
- (b) Agendas for the full Quorum Court and the committees shall be set by the chairperson of each committee and may be amended by the chairperson or a majority of the members.
- (c) Agendas must be submitted to the Quorum Court Secretariat no later than two business days (excluding holidays observed by the county) at 11:00 a.m. prior to any Quorum Court meeting.
- (d) Proposed items that are submitted after the agenda deadline may be considered at a meeting but will require a suspension of the rules before the proposed item can be introduced for consideration.

Article 7: The County Civil Attorney is hereby designated as legal counsel for the Quorum Court pursuant to A.C.A. §14-14-902(b).

Article 8: In accordance with A.C.A. §14-14-902, the County Clerk or the Clerk's designee is appointed as Secretariat of this Court. The duties of the Secretariat shall be as stated in A.C.A. §14-14-903(a)(3). The County Clerk or the Clerk's designee shall record all full court and committee meetings, with the exception of executive sessions.

Article 9: SPECIAL MEETINGS.

- (a) The county judge or a majority of the Quorum Court members may call a special meeting upon at least twenty-four (24) hours' notice. Such notice shall include the time, date, place, and subject of the meeting. Only the business stated in the notice of the call of the special meeting shall be considered at the meeting.
- (b) If notice of a special meeting is given at any regular or special Quorum Court meeting, it shall constitute due notice to the members present. The Secretariat shall be responsible for notifying those members who are absent.

Article 10: It is hereby recognized that immediate establishment of dates, times, and locations of the regular meetings of the Quorum Court and the Budget and Finance Committee thereof is necessary and is required by state law. Therefore, an emergency is declared to exist, and this Ordinance being necessary for preservation and protection of the public health, safety, and welfare of Faulkner County, this Ordinance shall be in force and take effect upon passage and publication.

Article 11: SEVERABILITY. If any part of this Ordinance is held invalid, such invalidity shall not affect any other portion of this Ordinance.

Article 12: REPEALER. All laws and parts of laws in conflict with this Ordinance are hereby repealed.



BE IT ENACTED BY THE QUORUM COURT OF FAULKNER COUNTY, STATE OF ARKANSAS,
AN ORDINANCE ENTITLED:

“AN ORDINANCE TO AMEND ORDINANCE 23-20 AND TO DECLARE AN EMERGENCY”

WHEREAS, Arkansas state law ACA 14-14-801 specifically states the powers of a county Quorum Court include the power to “preserve the peace and order and secure freedom from dangerous or noxious activities.”

WHEREAS, excessive noise in rural Faulkner County can be a dangerous and noxious activity, disturbing the peace and order in the areas affected by such noise.

WHEREAS, Act 173 of the 2024 fiscal session of the Arkansas Legislature amended the Arkansas Data Centers Act of 2023, and repealed restrictions that previously prevented county governments from effectively protecting citizens from the harm caused by excessive noise produced by crypto-mining facilities.

WHEREAS, with the passage of Act 173 in 2024, state law now permits this Court greater authority to regulate crypto-mining facilities to protect Faulkner County citizens from the harmful effects of such facilities.

WHEREAS, the restrictions on data centers enumerated in ordinance 23-20 have proven insufficient to provide relief to affected Faulkner County citizens.

WHEREAS, more crypto-mining facilities have expressed interest in opening in Faulkner County, threatening to torture more Faulkner County citizens absent sufficient regulation by this Court, regulation that is now permissible under state law.

THEREFORE, BE IT ORDAINED BY THE QUORUM COURT OF FAULKNER COUNTY, ARKANSAS, TO AMEND FAULKNER COUNTY ORDINANCE 23-20 AS FOLLOWS,

ARTICLE 1. Purpose and Applicability

All Data Centers constructed within this jurisdiction shall be designed and built to incorporate noise attenuation measures in order to minimize the impact of noise disturbance on the residents of Faulkner County, Arkansas.

This ordinance shall only apply to noise disturbances originating within the unincorporated areas of Faulkner County, Arkansas.

ARTICLE 2. Definitions

For the purpose of this Ordinance, the following definitions shall apply unless the context clearly indicates or requires a different meaning:

1. **Ambient Noise:** The all-encompassing noise level associated with a given environment, being a composite of sounds from all sources, excusing the alleged offensive noise, at the locations and approximate time at which comparison with the alleged offensive noise is to be made.
2. **“Blockchain network”** means a group of computers operating and processing together to execute a consensus mechanism to agree upon and verify data in a digital record.
3. **Data Center:** Industrial or commercial building or facility that houses IT infrastructure for building, running, and delivering applications and services, and for storing and managing the data associated with those applications and services including but is not limited to data asset mining businesses.
4. **Decibel (dB):** A unit for measuring the volume of a sound, equal to twenty (20) times to the base 10 (10) of the ratio of the pressure of the sound measured to the referenced pressure, which is twenty (20) micropascals (twenty (20) micronewtons per square meter.)
5. **“Digital Asset”** means cryptocurrency, virtual currency, and natively electronic assets, including without limitation stable coins, nonfungible tokens, and other digital-only assets, that confer economic, proprietary, or access rights or powers.
6. **“Digital Asset Mining”** means use of electricity to power a computer for the purpose of securing or validating a blockchain network.
7. **“Digital Asset Mining” Business** means a group of computers working at a single site that consumes more than one megawatt (1MW) on an average annual basis for the purpose of generating digital assets by securing a blockchain network.
8. **Mechanical Equipment:** The networked computer systems along with supporting equipment such as batteries, backup generators, and cooling systems housed on the Data Center's property.
9. **Noise Attenuation:** The reduction of noise levels through the use of sound-absorbing material, architectural design techniques, and/or any other suitable means.
10. **Noise Disturbance** is any sound which:
 - a. Endangers or injures the safety or health of humans or animals; or

- b. Annoys or disturbs a reasonable person of normal sensitivities; or
 - c. Endangers or injures person or property.; or
 - d. 60 dBa or higher during the hours of 8:00 a.m. to 8:00 p.m. or 55 dBa or higher during the hours of 8:00 p.m. to 8:00 a.m. measured at the property line of the receiving property.
- 11. **Person:** An individual, association, partnership, or corporation, including any officer, employee, department, or agency.
 - 12. **Property Line:** An imaginary line along the ground surface, and its vertical extension, which separates the property owned by one person from that owned by another person, but not including intra-building property divisions.
 - 13. **Sound:** An oscillation in pressure, particle displacement, particle velocity or other physical parameter, in a medium with internal forces that causes compression and rarefaction of that medium. The description of sound may include any characteristic of such sound, including duration, intensity and frequency.
 - 14. **Sound Level:** The weighted sound pressure level obtained by the use of a sound level meter and frequency weighting network, such as A, B, or C as specified in American National Standards Institute specifications for sound level meters (ANSI SI. 4-1971, or the latest approved revision thereof). If the frequency weighting employed is not indicated, the A-weighting shall apply.
 - 15. **Sound Level Meter:** An instrument which includes a microphone, an amplifier, RMS detector, integrator or time averager, output meter, and weighting networks used to measure sound pressure levels.

ARTICLE 3: Noise Attenuation Requirements

Before a Data Center has commenced construction or operating within this jurisdiction, the property owner and operator proposing to build a Data Center shall comply with the following:

- 1. **Notice Requirements**
 - a. The property owner and operator must notify the County Judge that the property owner and operator intends to build and operate a Data Center. The notification must include the location for the proposed Data Center. The County Clerk or County Judge's office must make public notice. The County Judge will add the proposed Data Center to the Quorum Court agenda within ninety (90) days of the notification of such proposed Data Center, for public comment.

2. Noise Study Requirements

- a. The property owner and/or operator of the lands upon which the Data Center is to be located shall conduct a sound study performed by a third party acoustic engineer to document baseline sound levels in the area of the proposed Data Center, including noise levels measured at the property line in eight locations (north, south, east, west, northeast, northwest, southeast, southwest.) The report of the study must include sound mitigation recommendations based on the results of the sound study. The property owner must provide a copy of the report of the study to the county judge and file with the county clerk within 30 days of completion of the report.

3. Noise Attenuation Plan Requirements

- a. The property owner and/or operator must consult with a third- party architectural or design firm to develop a building plan that includes necessary noise attenuation measures in order to prevent the external sound level as stated in Article 5, Section 1, emanating from the Data Center from exceeding the sound level limitations below which will be considered a noise disturbance. The building plan is not required to adopt any or all of the noise attenuation recommendations so long as the plan includes noise attenuation measures that the architectural or design firm deems adequate to be in compliance with this Ordinance. Noise attenuation measures may include, but not limited to
 - i. Soundproofing walls, screens, panels, fences, or sufficient enclosures.
 - ii. Buffer Yards
 - iii. Other noise attenuation measures recommended by the third-party acoustic engineer
- b. Mechanical equipment must be shown on any proposed plan and must be fully screened on all sides. Mechanical equipment not screened by a facade of the building must be screened by a visually solid fence, screen wall or panel, or parapet wall and constructed with a design, materials, details, and treatment compatible with those used on the nearest facade of the building.
- c. The property owner and/or operator must provide a copy of the building plan to the county judge and file with the county clerk within 30 days of completion of the plan prior to construction.
- d. Any additions, changes, or expansions of the Data Center must comply with the noise attenuation requirements of this Ordinance and must be designed and submitted to the county judge and file with the county clerk within 30 days of completion of the report.

4. Post Completion Noise Study Requirements

- a. Upon the Data Center's completion, the Data Center operator must conduct a post-construction noise study performed by a third-party acoustic engineer to document noise levels emanating from the Data Center when mechanical equipment is running at full capacity, including all HVAC units and generators necessary for peak operation. Noise levels are to be measured at the property line in the original eight locations used during the baseline study. The Data Center operator must provide a copy of the report to the county judge and file with the county clerk within 30 days of completion of the study.
- b. The Data Center shall not begin operations until the completion of the post-construction noise study and submission to the county judge and county clerk as required above. In order for the Data Center to be in compliance, the noise study results must show that its operation is in compliance with this Ordinance. If the results show that the Data Center is not in compliance with this Ordinance, the Data Center shall not commence operation until the required noise attenuation measures and noise limitations are met.
- c. Furthermore, the Data Center operator must conduct annual noise studies under the baseline and post-construction studies specifications in accordance with subsections (a) and (b) above. The Data Center operator must provide the results to the county judge and file with the county clerk within 30 days after the anniversary date of the first sound study report.

ARTICLE 4: Procedure for Measurement

All tests shall be conducted according to the following procedures:

1. **Complaint Driven:** When the measurement is the result of a complaint, measurements will be taken at the property line of the receiving property.
2. **Normal Monitoring:** When the measurement procedure is in the normal course of monitoring sound, the measurements will be taken at the property line of the source of the sound.
3. **Calibration:** The sound level meter must be calibrated at least every two years.
4. **Meter Placement:** The sound level meter must be placed a minimum of four feet above the ground or from any reflective surface. The microphone must be pointed at the sound source.
5. **Measurements:** Measurements must include "high", "average", and "low" readings. If the sound level meter does not provide these multiple readings, a minimum of three separate measurements must be taken at a single location at varying time

intervals. The average sound level reading shall be used to determine whether there has been a violation of this Ordinance.

6. Monitoring Report: The report for each measurement session must include:

- a. The day, date and time of the measurements,
- b. Date and time of recent calibration of the sound meter,
- c. Temperature,
- d. Identification of the monitoring equipment,
- e. Location, land use, and description of the source,
- f. Location and land use of the listener, and
- g. Sound level measurements.

7. Extraneous Sounds: If there are extraneous sound sources that are unrelated to the measurements and increase the monitored sound level, the measurement shall be postponed until these noises subside.

ARTICLE 5: Noise Limitations

It shall be unlawful for any Data Center to make or continue to cause or permit to be made or continued, noise levels constituting a noise disturbance. For the purposes of this section, the external noise level emanating from Data Centers shall be deemed disturbing to a person, reasonably calculated to disturb the peace and unreasonably offensive and injurious to the public, or their property, if the sound level is:

1. 60 dBa or higher during the hours of 8:00 a.m. to 8:00 p.m. or 55 dBa or higher during the hours of 8:00 p.m. to 8:00 a.m. measured at the property line of the receiving property.
2. The standard which may be considered in determining whether a violation of this Ordinance exists for a noise disturbance not meeting the threshold set forth in the immediately proceeding sentence includes, but is not limited to the following:
 - a. The level or volume of the noise;
 - b. The time of day or night the noise occurs;
 - c. The duration of the noise;
 - d. Whether the noise is recurrent, intermittent or constant; and
 - e. Whether proper and reasonable noise attenuation methods were followed and maintained

ARTICLE 6: Violations

1. Any or all of the following persons may be held responsible for noise violations:

- a. The person operating the equipment or creating the noise;
 - b. The person who employs the person operating the equipment or creating the noise at the time of the violation;
 - c. The person who owns or rents the property where the violation occurs.
2. The following acts, and the causing thereof, are declared to be in violation of this Ordinance:
 - a. The sound level emanating from the Data Center exceeds 60 dBa or higher during the hours of 8:00 a.m. to 8:00 p.m or 55 dBa or higher during the hours of 8:00 p.m. to 8:00 a.m. measured at the property line of the receiving property.
 - b. The noise attenuation measures provided in the design plan to the County Judge are not incorporated in the construction of the Data Center.
 - c. Any of the required sound study results are not filed with the County Judge and the County Clerk within 30 days of completion of the report.
 - d. The building plan is not filed with the County Judge and the County Clerk within 30 days of completion of the plan prior to construction.
 - e. Failure to act in accordance with any other provision of this Ordinance.
3. All Data Centers shall be in compliance with the requirements of this Ordinance before commencing operation; failure to do so will be deemed in violation of this Ordinance and result in an injunction and/or a stay in commencing operation.

ARTICLE 7: Penalties

1. Any person(s), firm, corporation, partnership, association, owner, occupant, agent or anyone having ownership in the subject property or supervision or control over the Data Center that violates or fails to comply with any provision of this Ordinance, shall be guilty of a misdemeanor.
2. Upon conviction of such violation, any offending party shall be punished by a fine of up to \$1,000 for any one specified offense or violation. Each day of a continuing violation constitutes a separate violation. Furthermore, if the prohibited act continues after the conviction of a violation, a court may issue a fine in an amount up to \$500 for each day that the unlawful conduct continues. Additionally, the County may petition for an injunction in a court of proper jurisdiction to abate the nuisance.
3. The county or any citizen shall be entitled to pursue all legal and equitable remedies available under the law in order to abate the nuisance and compel compliance with this Ordinance, including injunctive relief and any civil damages the court deems appropriate.

4. Until the Data Center is in compliance with this Ordinance and required noise attenuation measures are implemented and noise limitations met, the Data Center shall cease operations.

ARTICLE 8: Severability

If any provision of this Ordinance is found to be invalid by the decision of any court of competent jurisdiction, such invalidity shall not affect the remaining sections, phrases, and provisions of this Ordinance which shall remain valid and enforceable.

ARTICLE 9: Emergency Clause

The Quorum Court finds that the immediate implementation of this ordinance is necessary for the preservation of the public's peace, health, safety, welfare, and property, an emergency is hereby declared to exist and that this Ordinance is to be in effect immediately after its adoption.





Be it enacted by the Quorum Court of Faulkner County, State of Arkansas. An Ordinance to be entitled: An appropriation Ordinance to amend and supplement Faulkner County Ordinance 24-52 (November 20, 2024) in order to create one (1) new position for "School Resource Officer", pursuant to the proposed Memorandum of Understanding between Mt.
