The Faulkner County Quorum Court met in its regular session at 6:00 PM on August 19, 2025, in Courtroom "4" located in the Faulkner County Justice Building with Judge Allen Dodson presiding.

**Approval of the Journal:** Justice Kendrick made a motion that the Journal of Proceedings be approved, and such motion was seconded by Justice Shock. The Journal was unanimously approved.

**County Officer's Report**: The Treasurer's report was provided to the Court on the Financial Standing of the County and a copy is on file.

and Proposed Ordinance 25-19 passed with a vote of 7-4, with Justices Allision, Meeks, Shock, and Tyler voting no.

After discussion, Judge Dodson called for a vote by roll call for Proposed Ordinance 25-22. The roll was called and Proposed Ordinance 25-22 passed with a vote of 11-0.
