After discussion, Judge Dodson called for a vote by roll call for Proposed Ordinance 25-24. The roll was called and Proposed Ordinance 25-24 passed with a vote of 13-0.

The Court discussed Proposed Ordinance 25-25. This is an Ordinance to create a new position in Victim Witness, Department 0429, and to declare an emergency. Justice Kendrick made a motion to accept Proposed Ordinance 25-25, and such motion was seconded by Justice Coats. Counsel Murphy read Proposed Ordinance 25-25 by title only. After discussion, Judge Dodson called for a vote by roll call for Proposed Ordinance 25-25. The roll was called and Proposed Ordinance 25-25 passed with a vote of 13-0.

The Court discussed Proposed Ordinance 25-26. This is an Ordinance to set the compensation of Election Coordinator, Position 1001, and to declare an emergency. Justice Kendrick made a motion to accept Proposed Ordinance 25-26, and such motion was seconded by Justice Lyon. Counsel Murphy read Proposed Ordinance 25-26 by title only. After discussion, Judge Dodson called for a vote by roll call for Proposed Ordinance 25-26. The roll was called and Proposed Ordinance 25-26 was passed with a vote of 13-0.

The Court discussed Proposed Ordinance 25-27. This is an Ordinance to reclassify a job title, to amend and supplement Faulkner County Ordinance 24-52 (November 20, 2024), and to declare an emergency. Justice Lachowsky made a motion to accept Proposed Ordinance 25-27, and such motion was seconded by Justice Knight. After discussion, Judge Dodson called for a vote by roll call for Proposed Ordinance 25-27. The roll was called and Proposed Ordinance 25-27 was passed with a vote of 13-0.

Marcus Shock was presented for appointment to the Museum Board by Judge Dodson. Justice Kendrick made a motion to approve the appointment of Marcus Shock to the Museum Board, and such motion was seconded by Justice Moss. The appointment was unanimously approved.
