

PROPOSED ORDINANCE 25-29

Be it enacted by the Quorum Court of the County of Faulkner, State of Arkansas. An Ordinance to be entitled: An appropriation Ordinance to amend and supplement Faulkner County Ordinance 24-52 as a one-time pay increase of \$400.00 for all full-time employees and \$200.00 for part-time employees, to be paid with a payroll date of November 21, 2025, and to declare an emergency.
