

PROPOSED ORDINANCE 25-31

Sponsored by Budget & Finance Committee

Be it enacted by the Quorum Court of the County of Faulkner, State of Arkansas.

An Ordinance to be entitled: An appropriation Ordinance to amend and supplement Faulkner County Ordinance 24-25 (November 20, 2024), and to declare an emergency.

- Section 1: \$1,000.00 is transferred within County General Fund (1000), Department 0109, Election Commission/Voter Registration, from expenditure code 4004 – Machinery & Equipment to expenditure code 3009 – Other Professional Services.
- Section 2: \$2,400.00 is transferred within County General Fund (1000), Department 0419, Coroner, from expenditure code 2008 – Tires & Tubs to expenditure code 4004 – Machinery & Equipment.
- Section 3: \$13.25 is transferred within County General Fund (1000), Department 0417, Public Defender, from expenditure code 1011 – Unemployment to expenditure code 3009 – Other Professional Services.
- Section 4: \$11,388.16 is anticipated/projected to Criminal Justice Fund (3407).
(Revenue Series Code 7154)
- \$11,388.16 is appropriated from Criminal Justice Fund (3407) to Department 0436, Deputies, expenditure code 1005 – Overtime.
- Section 5: \$45,000.00 is transferred within County General Fund (1000), from Department 0400, Sheriff, expenditure code 1001 – Salaries, Full-Time, to expenditure code 1005 – Overtime.
- Section 6: \$40,000.00 is transferred within County General Fund (1000), from Department 0418, County Jail, expenditure code 1001 – Salaries, Full-Time, to expenditure code 1005 – Overtime.
- Section 7: \$78,000.00 is transferred within Criminal Justice Fund (3407), from Department 0421, Criminal Justice Sales Tax, expenditure code 1001 – Salaries, Full-Time, to expenditure code 1005 – Overtime.
- Section 8: \$24,685.95 is transferred within Criminal Justice Fund (3407), from Department 0436, Criminal Justice Sales Tax, as follows:

- Section 9: \$5,610.41 is transferred within Rapid DNA Fund (3531), Department 0400, Sheriff, from expenditure code 2001 – General Supplies to expenditure code 4004 – Machinery & Equipment.

- Section 10: \$500.00 is transferred within County General Fund (1000), Department 0500, Office of Emergency Management, from expenditure code 1010 – Workers’ Compensation to expenditure code 1005 – Overtime.
- Section 11: \$2,000.00 transferred within County General Fund (1000), Department 0107, Quorum Court, from expenditure code 1002 – Salaries, Part-Time to expenditure code 2002 – Small Equipment.
- Section 12: The adoption of this Ordinance is an emergency and therefore, an emergency is hereby declared to exist, and this Ordinance shall be in full force and effect immediately upon its passage and approval.
