

PROPOSED ORDINANCE 25-34

Sponsored by Budget & Finance Committee

Be it enacted by the Quorum Court of the County of Faulkner, State of Arkansas.

An Ordinance to be entitled: An appropriation Ordinance to amend and supplement Faulkner County Ordinance 25-33 (November 18, 2025), and to declare an emergency.

Section 1: \$9,837.60 transferred within County General Fund (1000), Department 0800, Veteran's Service, to Department 0108, Maintenance, as follows:

Section 2: \$281.78 is anticipated/projected to Collector's Automation Fund (3001).
(Revenue Series Code 8762)

\$281.78 is appropriated from Collector's Automation Fund (3001) to Department 6000, Clearing Account, line-item code 6554, AFLAC.

Section 3: \$125,000.00 is appropriated from 911/PSAP Fund (3020) to Department 0501, 911, expenditure code 3100 – Other Miscellaneous.

Section 4: \$1,600.00 is transferred with County General Fund (1000), Department 0409, District Court, from expenditure code 1010 – Workmen's Comp to expenditure code 1001 – Salaries, Full-Time.

Section 5: \$5,000.00 is transferred within County General Fund (1000), Department 0115, IT, from expenditure code 3009 – Other Miscellaneous to expenditure code 4004 – Machinery & Equipment.

Section 6: \$6,000.00 is transferred within County General Fund (1000), Department 0115, IT, from expenditure code 3009 – Other Miscellaneous to expenditure code 2002 – Small Equipment.

Section 7: \$13,801.60 is anticipated/projected to County General Fund (1000).
(Revenue Series Code 8762)

\$13,801.60 is appropriated from County General Fund (1000) to Department 0109, Elections/Voter Registration, as follows:

\$5,563.00	1002 – Salaries, P/T
\$ 700.00	2001 – General Supplies
\$6,500.00	3009 – Other Professional Services
\$ 888.60	3040 – Advertising & Publications
\$ 150.00	3023 - Internet Connection

Section 8: \$55,000.00 is transferred within Criminal Justice Sales Tax Fund (3407, Department 0421, Criminal Justice Sales Tax, from expenditure code 2005 – Food to expenditure code 3069 – Utilities.

Section 9: The adoption of this Ordinance is an emergency and therefore, an emergency is hereby declared to exist, and this Ordinance shall be in full force and effect immediately upon its passage and approval.
