

**PROPOSED ORDINANCE 26-08**  
Sponsored by Budget & Finance Committee

**Be it enacted by the Quorum Court of the County of Faulkner, State of Arkansas.  
An Ordinance to be entitled: An appropriation Ordinance to amend and supplement Faulkner County Ordinance 25-33 (November 18, 2025), and to declare an emergency.**

- Section 1: \$15,000.00 is anticipated/projected to Criminal Justice Fund (3407).  
(Revenue Series Code 8718)
- \$15,000.00 is appropriated from Criminal Justice Fund (3407) to Department 0436, Deputies, to expenditure code 4005 - Vehicles
- Section 2: \$661.70 is appropriated within Circuit/District Court Grant Fund (3511), from Department 0436, Court Security Grant, expenditure code 3093 – Misc. Law Enforcement Equipment.
- Section 3: \$40.24 is appropriated within JAG Grant Fund (3513), from Department 0513, JAG Grant, expenditure code 3093 – Misc. Law Enforcement Equipment.
- Section 4: \$11,518.08 is transferred from County General Fund (1000) to ARORP ORT Grant Fund (3527). (Revenue Code 8952)
- Section 5: \$2,935.97 is appropriated as a transfer from County General Fund (1000) to ARORP ORT Grant Fund (3527)
- \$2,935.97 is anticipated/projected to ARORP ORT Grant Fund (3527).  
(Revenue Series Code 8952)
- \$2,935.97 is appropriated from ARORP ORT Fund (3527) to Department 0450, ARORP ORT, to expenditure code 3102 – Computer Software.
- Section 6: Due to expenses incurred on December 31, 2025, \$58,725.00 is reduced from RAPID DNA Grant Fund (3531), Department 0400, Sheriff, expenditure code 2001 – General Supplies, the total 2026 appropriation for expenditure code 2001 is \$255,407.31.
- Section 7: \$8,489.86 is transferred from Sheriff's Pass-through Grants Fund (3529) to County General Fund (1000). (Revenue Series Code 8885)
- Section 8: \$4,030.62 is transferred from Sheriff's Pass-through Grants Fund (3529) to Criminal Justice Sales Tax Fund (3407). (Revenue Series Code 8885).
- Section 9: The adoption of this Ordinance is an emergency and therefore, an emergency is hereby declared to exist, and this Ordinance shall be in full force and effect immediately upon its passage and approval.
