Sponsored by Budget & Finance Committee

Be it enacted by the Quorum Court of the County of Faulkner, State of Arkansas.
An Ordinance to be entitled: An appropriation Ordinance to amend and supplement
Faulkner County Ordinance 25-33 (November 18, 2025), and to declare an emergency.

- Section 1: \$ 60,000.00 is appropriated from Animal Welfare & Control Fund (3404) to Department 0406, Animal Welfare & Control, Expenditure Code 3104 - Spay & Neuter Services.
- Section 2: \$16.26 is anticipated/projected to Criminal Justice Sales Tax Fund (3407).
