

PROPOSED ORDINANCE 26-16
Sponsored by Budget & Finance Committee

**Be it enacted by the Quorum Court of the County of Faulkner, State of Arkansas.
An Ordinance to be entitled: An appropriation Ordinance to amend and supplement
Faulkner County Ordinance 25-33 (November 18, 2025), and to declare an emergency.**

WHEREAS, the Faulkner County Circuit Clerk’s Office in 2022 move five positions funded out of County General Fund (1000), Department 0102 (Circuit Clerk) to the County Recorders Cost Fund (3006), Department 0120, County Recorder’s Cost; and

WHEREAS, the Faulkner County Circuit Clerk, at their discretion, pursuant to A.C.A. § 21-6-306 (c)(1), shall use the funds in County Recorders Cost fund (3006) to offset administrative costs; and

WHEREAS, pursuant to such change in 2022, the Faulkner County Circuit Clerk’s County Recorders Cost fund (3006) funds have been reduced significantly and now needs to transfer back two full-time position and the parti-time position of the cost back to County General Fund (1000); and

NOW, THEREFORE, BE IT ORDAINED by the Quorum Court of Faulkner County, Arkansas:

Section 1: The following position codes are transferred from Fund (3006) County Recorder’s Cost, Department (0120) County Recorder’s Cost to County General Fund (1000), Department (0102) Circuit Clerk:

Section 2: \$215,555.48 is appropriated from County General Fund (1000) to Department 0102, Circuit Clerk, as follows:
