

PROPOSED ORDINANCE 26-19
Sponsored by Budget & Finance Committee

Be it enacted by the Quorum Court of the County of Faulkner, State of Arkansas.
An Ordinance to be entitled: An appropriation Ordinance to amend and supplement Faulkner County Ordinance 25-33 (November 18, 2025), and to declare an emergency.

Section 1: \$48,515.00 is anticipated/projected to Criminal Justice Fund (3407).
 (Revenue Series Code 8718)

\$48,515.00 is appropriated from Criminal Justice Fund (3407) to Department 0436, Deputies, to expenditure code 4005 – Vehicles.

Section 2: \$27,444.90 is transferred within Criminal Justice Fund (3407), Department 0436, Deputies, from expenditure code 4005 – Vehicles to expenditure code 2032 – Parts & Repairs-Vehicles.

Section 3: \$770.81 is anticipated/projected to Criminal Justice Fund (3407).
 (Revenue Series Code 8762)

\$770.81 is appropriated from Criminal Justice Fund (3407) to Department 0436, Deputies, to expenditure code 2007 – Fuels, Oils, & Lubricates.

Section 4: \$6,705.15 is anticipated/projected to Criminal Justice Fund (3407).
 (Revenue Series Code 7154)

\$6,705.15 is appropriated from Criminal Justice Fund (3407) to Department 0436, Deputies, to expenditure code 1005 – Overtime.

Section 5: \$6,001.88 is appropriated as a transfer from Sheriff's Pass-through Grants Fund (3529) to County General Fund (1000).

\$6,001.88 is anticipated/projected to County General Fund (1000). (Revenue Series Code 8885).

\$6,001.88 is appropriated from County General Fund (1000) to Department 0400, Sheriff, to expenditure code 1005 – Overtime.

Section 6: \$4,303.32 is appropriated as a transfer from Sheriff's Pass-through Grants Fund (3529) to Criminal Justice Sales Tax Fund (3407).

\$4,303.32 is anticipated/projected to Criminal Justice Sales Tax Fund (3407). (Revenue Series Code 8885).

\$4,303.32 is appropriated from Criminal Justice Sales Tax Fund (3407) to Department 0436, Deputies, as follows:

\$2,103.32	1005 – Overtime
\$2,200.00	3093 – Misc. Law Enforcement Equipment

Section 7: \$50,000.00 is transferred within County General Fund (1000), from Department 0400, Sheriff, as follows:

\$25,000.00	1002 – Salaries, Part-Time	1005 – Overtime
\$25,000.00	1001 – Salaries, Full-Time	1005 – Overtime

Section 8: \$100,000.00 is transferred within County General Fund (1000), from Department 0418, County Jail, expenditure code 1001 – Salaries, Full-Time, to expenditure code 1005 – Overtime.

Section 9: \$134,000.00 is transferred within Criminal Justice Sales Tax Fund (3407), from Department 0421, Criminal Justice Sales Tax-Jail, as follows:

\$ 4,000.00	1002 – Salaries, Part-Time	1005 – Overtime
\$130,000.00	1001 – Salaries, Full-Time	1005 – Overtime

Section 10: The adoption of this Ordinance is an emergency and therefore, an emergency is hereby declared to exist, and this Ordinance shall be in full force and effect immediately upon its passage and approval.
