

PROPOSED ORDINANCE 26-21
Sponsored by Budget & Finance Committee

Be it enacted by the Quorum Court of the County of Faulkner, State of Arkansas.
An Ordinance to be entitled: An appropriation Ordinance to amend and supplement
Faulkner County Ordinance 25-33 (November 18, 2025), and to declare an emergency.

- Section 1: \$1,700.00 is transferred within County General Fund (1000), Department 0108, Maintenance, from expenditure code 2023 – Parts & Repairs to expenditure code 4005 – Vehicles.
- Section 2: \$100.00 is anticipated/projected in County General Fund (1000).
(Revenue Series Code 8701)
- \$100.00 is appropriated from County General Fund (1000) to Department 0500, Office of Emergency Management, expenditure code 3100 - Other Miscellaneous
- Section 3: \$11,000.00 is transferred within Animal Welfare Control Fund (3404), Department 0406, Animal Welfare Control, as follows:

- \$369.60 is appropriated from County General Fund (1000) to Department 0101, County Clerk, expenditure code 3094 – Meals & Lodging.
- Section 5: \$45,000.00 is transferred within County Road Fund (2000), Department 0200, County Road, from expenditure code 2025 – Asphalt to expenditure code 1002 – Salaries, Part-time.
- Section 6: \$94.29 is transferred within Elections Grant Fund (3530), Department 0109, Elections/Voter Registration, as follows:
