

PROPOSED ORDINANCE 26-25
Sponsored by Budget & Finance Committee

Be it enacted by the Quorum Court of the County of Faulkner, State of Arkansas.
An Ordinance to be entitled: An appropriation Ordinance to amend and
supplement Faulkner County Ordinance 25-33 (November 18, 2025), and to
declare an emergency.

Section 1: \$7,808.00 is anticipated/projected in Homeland Security SHSGP Grant Fund (3503). (Revenue Series Code 7105)

\$7,808.00 is appropriated from Homeland Security SHSGP Grant Fund (3503) to Department 0502, Homeland Security SHSGP Grant, as follows:

\$ 75.00	2002 – Small Equipment
\$7,733.00	4004 – Machinery & Equipment

Section 2: \$1,000 is anticipated/projected in County General Fund (1000). (Revenue Series Code 8701)

\$1,000 is appropriated from County General Fund (1000) to Department 0500, Office of Emergency Management, to expenditure code 3100 – Other Miscellaneous.

Section 3: \$1,059,207.71 is appropriated from ARPA Revenue Replacement Fund (1006) to Department 0418, County Jail, expenditure Code 4006 – Construction in Progress.

Section 4: \$6,500.00 is anticipated/projected to County General Fund (1000). (Revenue Series Code (8719)

\$6,500.00 is appropriated from County General Fund (1000) to Department (0101) County Clerk, as follows:

\$1,500.00	1005 – Overtime
\$2,000.00	2001 – General Supplies
\$3,000.00	3009 – Other Professional Services

Section 5: \$40,000.00 is anticipated/projected to County General Fund (1000). (Revenue Series Code 8719)

\$40,00.00 is appropriated from County General Fund (1000) to Department (0109) Elections/Voter Registration, as follows:

\$ 1,500.00	1005 – Overtime
\$ 5,000.00	2001 – General Supplies
\$25,000.00	3009 – Other Professional Services
\$ 2,500.00	3023 – Internet Connection
\$ 6,000.00	3102 – Computer Software, etc.

Section 6: \$5,000.00 is anticipated/projected to Juvenile Court Grant Fund (3505).
(Revenue Series Code 7010)

\$5,000.00 is appropriated from Juvenile Court Grant Fund (3505) to Department
(0434) Juvenile Court Grant, as follows:

\$1,000.00	2001 – General Supplies
\$2,000.00	3030 – Travel
\$2,000.00	3101 – Training and Education

Section 7: The adoption of this Ordinance is an emergency and therefore, an emergency is
hereby declared to exist, and this Ordinance shall be in full force and effect
immediately upon its passage and approval.
